Job Summary

The Medical Clinic Coordinator is responsible for maintaining high quality and efficient medical activities for Genesis Community Heealth in Canyon County.

Duties and Responsibilities

Patient Care

- Work closely with other clinic staff to coordinate patient care
- Oversee chart review and preparation for each week's clinics
- Chronic disease management
- During work hours, be available to assist patients with medical concerns
- Screen potential patients to ensure their needs meet the clinic's scope of practice
- Pray for patients if requested

Personnel Coordination

- Manage medical clinic staff and volunteers to foster high quality and compassionate care
- Coordinate medical outreach activities and special programs
- Orient and train medical volunteers and staff
- Coordinate clinic intern programs with local educational institutions
- Direct workflow for medical clinic
- Fill-in as needed in clinic to ensure patient care is complete

Quality Management

- Define scope of practice and care protocols for the medical clinic in coordination with Medical Director, Director of Operations, and Garden City Medical Coordinator.
- Develop and maintain medical clinic policies and procedures with Garden City Medical Coordinator
- With Front Office Coordinator, maintain medical clinic outcome data

- Must be available to work at evening clinics when needed
- Experience working in a primary care setting

- Able to work clinic hours as assigned
- Ability to pray for patients
